POLICY FOR GROUP CAMPING RESERVATIONS

The camping sites in the lower area at Stanton Park (below the caretaker's residence, right side) may be reserved for a fee of \$200.00 per night. Douglas County resident discounts and veterans/active military discounts do not apply.

There are 13 sites; 7 of them are full hookups and 6 are tent sites. RV's may park in tent sites. The maximum number of RV's that will be allowed in this area is 13. RV's may not be parked out of the established sites. Any RV's over 13 will have to camp in another campsite outside of the reserved area on a first-come, first-served basis and pay the regular site fee. If all 13 sites are occupied, additional tents are permitted at the cost of \$5 per tent.

The full hookup sites are 31, 32, 33, 34, 36, 38 and 40. Tent sites are 35, 37, 39, 41, 42 and 43 (see map). The length of the sites is indicated on the map.

If your group doesn't have enough people to fill all the campsites, the fee will still be \$200.00.

Electrical cords from RV sites to Tent sites are not permitted.

Parked vehicles blocking any roads in the group camping area will not be allowed.

Roads must be kept open for emergency access.

Campsite:

A campsite is a physical site that will accommodate one camping unit and one tow vehicle per campsite. A camping unit is defined as any unit that is used for sleeping, such as a motor home, 5th wheel, tent, van, car, pickup with canopy, camper, etc. A tow vehicle is either a vehicle being towed or the vehicle towing the camping unit.

Any extra vehicles that cannot be parked in a paved campsite will have to park in the upper parking area by the pavilion. There will be no parking of RV's or vehicles on the grass in the reserved area. There are no extra-vehicle charges in group camping.

One person should be designated to be in charge and to pay the Caretaker the group camping fees upon arrival. Check in time is 2:30 pm. Check out time is 1:30 pm.

Deposit

The first night's fee of \$200.00 plus a \$10 non-refundable reservation fee is required to make the reservation. This can be done with a VISA or Mastercard credit card, or a VISA or Mastercard debit card.

Refund

The first night's fee may be refunded if the reservation is cancelled at least 30 days prior to the date of your arrival. The \$10 reservation fee is non-refundable.

Please contact the office if you wish to cancel your reservation.

The Park Office starts taking reservations 11 months in advance. You are encouraged to call us at 541-957-7001 as soon as possible. Our office hours are 8:00 a.m. to 4:30 p.m., Monday through Friday. Reservations are taken from 10:00 a.m. to 2:00 p.m. Address: PO Box 800 Winchester, OR 97495
