

# WINDY COVE 'B' CAMPGROUND

Windy Cove Campground, located adjacent to Highway 101 in Winchester Bay just four miles south of Reedsport offers complete camping facilities for RV'S, pickup campers and tents. Situated in the heart of recreational activity on Douglas County's coast line, Windy Cove Campground is a great place to stay and enjoy such activities as sport fishing, ORV riding in the Dunes NRA area, a tour of the Umpqua River Lighthouse and Coastal Visitor Center or just a quiet walk on the beautiful beaches.

Windy Cove 'B' campground has (40) full hook-up RV campsites; (22) of which are reservable and (29) tent (non hook-up) sites; (8) of which are reservable. To make a reservation (must be made 2 weeks ahead of arrival), please contact the Park office at 541-957-7001 between 10:00 am and 2:00 pm, Monday through Friday. Full hook-up sites: \$23.00 [Peak Season\*] or \$20.00 [Off Season\*\*] per night; non hook-up sites: \$15.00 per night. A \$2.00 discount applies to Douglas County residents. Holiday reservations require 50% prepayment. Reservations may be made from eleven months to two weeks prior to the arrival date. There is a \$10.00 non-refundable reservation fee. An administration fee of \$10 will be charged for any modification or cancellation of a reservation. Cancellation Policy for Individual Sites: 2 weeks prior to arrival date [30 days on holidays]. To make a reservation, please contact the Park office at 541-957-7001 between 10:00 am and 2:00 pm, Monday through Friday.

Our camp rules are:

Non-reservable campsites are maintained on a first come, first serve basis. This means physical presence is required to register for a campsite. By physical presence we mean the person who is to occupy the site must be present, with his or her camping unit, ready to physically occupy the site.

**CAMPSITE** - A physical site that will accommodate one camping unit and one tow vehicle. A camping unit is defined as any unit that is used for sleeping, such as a motorhome, 5th. wheel, tent, van, car, pickup with canopy or camper. A tow vehicle is either a vehicle being towed or the vehicle towing the camping unit. A small tent is permitted to accompany the primary camping unit in the campsite. A small tent is defined as a tent designed to be occupied by two or three people. Sleeping bags are not permitted on the ground and must be kept inside the camping unit. Any vehicles other than tow vehicles are considered extra vehicles and must pay the extra vehicle fee if they spend the night.

Check out time is 1:30 pm. If you plan to stay another night, please pay the Caretaker by this time.

SHOWER hours are 7:00 am to 9:00 am and 6:00 pm to 9:30 pm.

Fires are allowed in designated areas only. Camp stoves may be used in established campsites. Firewood must be kept in a neatly stacked pile. Do not leave a fire or portable stove unattended.

As the park is a game sanctuary, discharging of firearms is prohibited.

BE GOOD NEIGHBORS and keep your camp neat, clean and orderly. Deposit trash in the containers provided and leave your campsite as clean as you found it.

All pets must be kept on a leash. Please do not permit your animal to run wild, disturb other park users, or the wildlife. Please clean up after your pet.

QUIET TIME will be considered from 10:00 pm until 7:00 am in the morning. During this time please be considerate of your neighbors. Please keep your pets quiet, do not run generators, play music, or engage in loud behavior.

All vehicles, including trail bicycles and ORV's will travel and park within the designated roads and parking areas and will maintain a speed limit of 10 miles per hour or less.

Camper stay limits: May 15 to September 15, ten days out of every fourteen. September 16 to May 14, fourteen days out of every eighteen.

\* Peak Season: May 1<sup>st</sup> through September 30<sup>th</sup>.

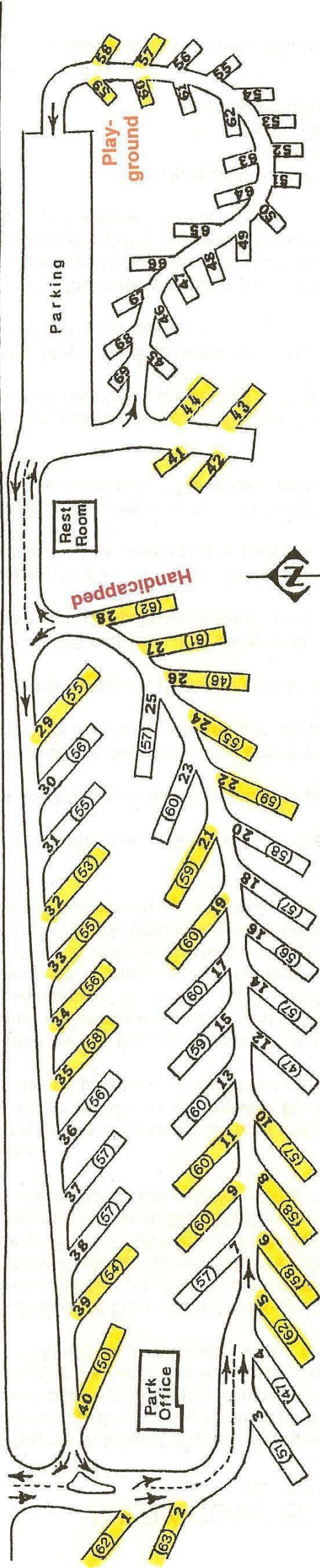
\*\*Off Season: October 1<sup>st</sup> through April 30<sup>th</sup>
