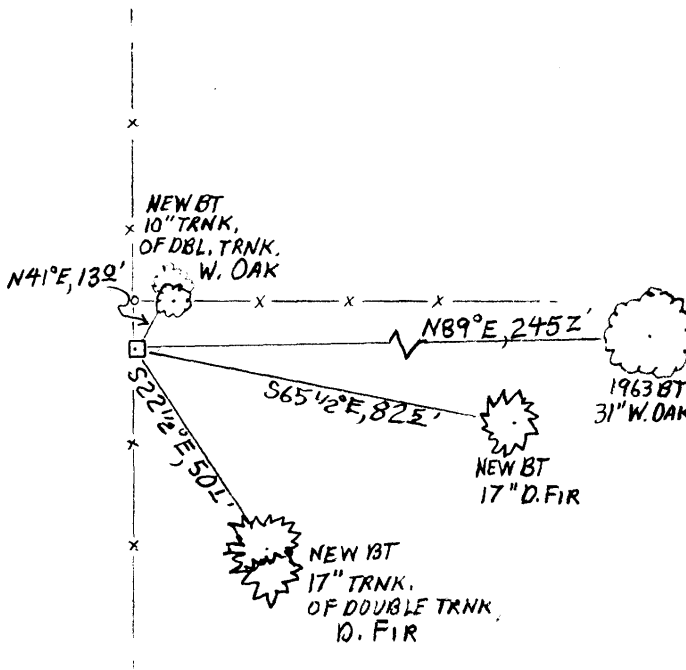
A DOUBLE-TRUNK DOUGLAS FIR THE NORTHERLY 21 INCH DIAM. TRUNK OF WHICH IS SCRIBED "SWDLC 47" "CSBT" ON A DOUBLE BLAZE. THE C.R.C. OF THIS TREE BEARS S22 1/2° E, 50 1/2 FEET DISTANT.

A DOUBLE-TRUNK WHITE OAK (GROWING AGAINST AN E-W FENCE) THE SOUTHERLY 10 INCH DIAM. TRUNK OF WHICH IS SCRIBED "CSBT" ON A HIGH BLAZE (4" ABOVE GROUND). THE C.R.C. OF THIS TREE BEARS N41° E, 13 1/2 FEET DISTANT.
