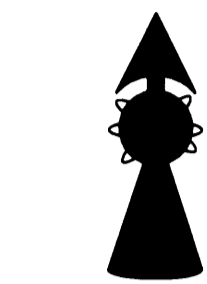


OVERALL SITE

NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO PARTITION THE SUBJECT PROPERTY INTO THREE PARCELS AS SHOWN. THE EASEMENT DESCRIBED IN INSTRUMENT NO. 81-10219, ACTUALLY MONUMENTED IN THE SURVEY FILED AS M155-38, WAS MARKED BEGINNING AT 450 FEET NORTHERLY OF THE SECTION CORNER RATHER THAN 458 FEET AS CALLED FOR IN THE DEED AND TAKEN TO THE ACTUAL RIGHT-OF-WAY OF CLEVELAND HILL ROAD SO THAT THE ACTUAL EXISTING ROAD WOULD BE INSIDE OF THE EASEMENT AREA.
