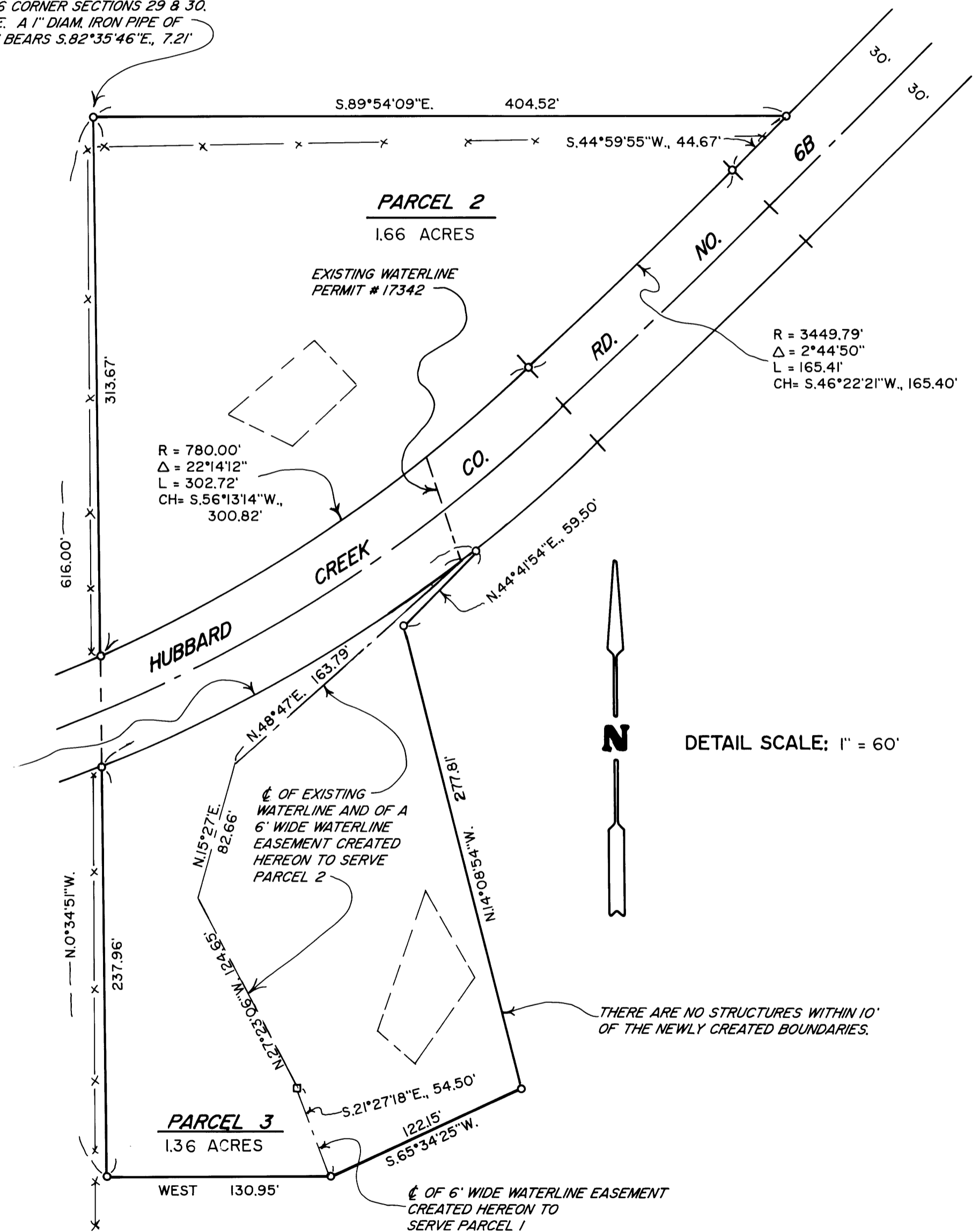

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO SHOW THE PARTITIONING OF THE GERMOND TRACT INTO THREE SEPARATE PARCELS, TO MONUMENT PARCELS 2 AND 3, AND TO CREATE A WATERLINE EASEMENT, ALL AS SHOWN HEREON. EXISTING CONTROL POINTS AND DATA PER MY SURVEY M 149-71 WERE USED FOR CONTROL. A TIE WAS MADE TO THE NW CORNER OF SECTION 29 IN ORDER TO COMPUTE AND MONUMENT THE NORTH 1/16 CORNER COMMON TO SECTIONS 29 AND 30. THE COUNTY ROAD WAS COMPUTED BASED ON TIES TO THE EXISTING CENTERLINE STRIPE.

NOTE: THE ACREAGE OF PARCEL 1 IS BASED UPON COUNTY ASSESSOR DATA.
