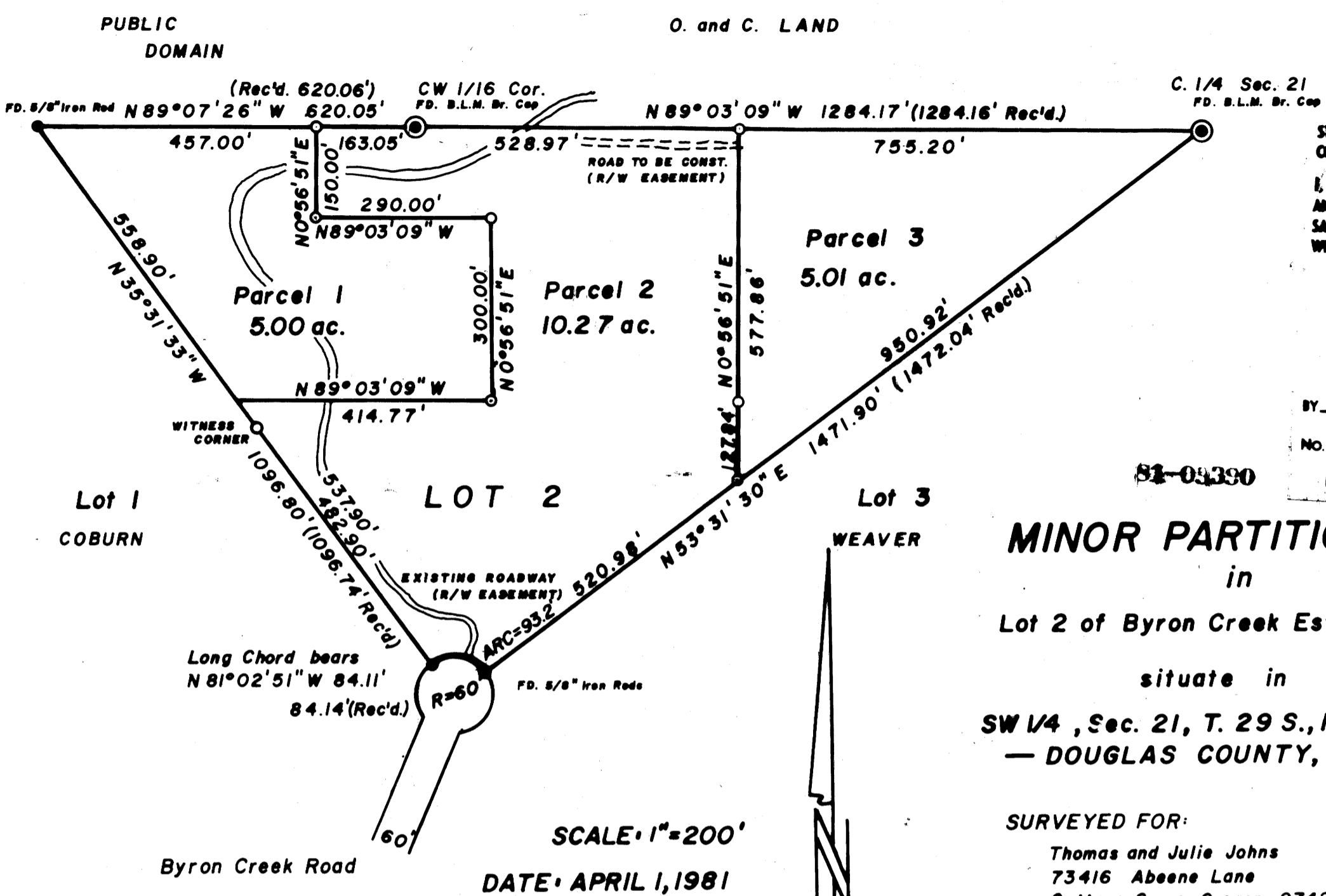

DESCRIPTIONS

PARCEL 1: Beginning at a point on the North Line of Lot 2 of Byron Creek Estates Partition (Survey No. RM 2-35), said point being N 89° 07'26" W, 163.05 ft. from the CW 1/16 Corner of Section 21, T. 29 S., R. 7 W., Willamette Meridian, Douglas County, Oregon; thence S 0° 56'51" W, 150.00 ft. to a 1 1/4" Iron Rod; thence S 89° 03'09" E, 290.00 ft. to a 1 1/4" Iron Rod; thence S 0° 56'51" W, 300.00 ft. to a 1 1/4" Iron Rod; thence N 89° 03'09" W, 414.77 ft. to the West Line of said Lot 2; thence N 35° 31'33" W, 558.90 ft. to the NW Corner of Lot 2; thence S 89° 07'26" E, 457.00 ft. to the point of beginning. Including Right of Way Easement below.

PARCEL 2: Beginning at a point on the North Line of Lot 2 of Byron Creek Estates Partition (Survey No. RM 2-35), said point being N 89° 07'26" W, 163.05 ft. from the CW 1/16 Corner of Section 21, T. 29 S., R. 7 W., Willamette Meridian, Douglas County, Oregon; thence S 0° 56'51" W, 150.00 ft. to a 1 1/4" Iron Rod; thence S 89° 03'09" E, 290.00 ft. to a 1 1/4" Iron Rod; thence S 0° 56'51" W, 300.00 ft. to a 1 1/4" Iron Rod; thence N 89° 03'09" W, 414.77 ft. to the West Line of said Lot 2; from which bears a witness corner located S 35° 31'33" E 55.00 ft.; thence S 35° 31'33" E along said West Line, 537.90 ft. to the Right of Way of Byron Creek Road; thence along said Right of Way around a curve to the right the chord of which bears S 81° 02'51" E, 84.11 ft. to a 5/8" Iron Rod, thence N 53° 31'30" E along the East Line of Lot 2, 520.98 ft. to a 1 1/4" Iron Rod; thence N 0° 56'51" E, 577.86 ft. to the North of Lot 2; thence N 89° 03'09" W along said North Line, 528.97 ft. to the CW 1/16 Corner of said Section 21; thence N 89° 07'26" W, 163.05 ft. to the point of beginning. Including Right of Way Easement below.

PARCEL 3: Beginning at a point on the North Line of Lot 2 of Byron Creek Estates Partition (Survey No. RM 2-35); said point being S 89° 03'09" E, 528.97 ft. from the CW 1/16 Corner of Section 21, T. 29 S., R. 7 W., Willamette Meridian, Douglas County, Oregon; thence S 0° 56'51" W, 577.86 ft. to the East Line of said Lot 2; thence N 53° 31'30" E along said East Line, 950.92 ft. to the Center 1/4 Corner of said Section 21; thence N 89° 03'09" W, 755.20 ft. to the point of beginning. Including Right of Way Easement below.

RIGHT OF WAY EASEMENT: Parcel 1 and Parcel 2 subject to Right of Way Easement 30 ft. in width beginning at the Right of Way of Byron Creek Road and meandering over Parcels 1 and 2 along an existing roadway, and along a designated location for new construction, as shown on the plat, giving continuous access over and across parcels 1 and 2 for parcel 3 but reserving joint usage thereof for parcels 1 and 2.

NARRATIVE OF SURVEY in Lot 2 of Byron Creek Estates Partition (Survey No. RM 2-35), in the SW $\frac{1}{4}$ of Section 21, Township 29 South, Range 7 West, Willamette Meridian, Douglas County, Oregon.

FOR: Thomas and Julie Johns, owners of said Lot 2.

PURPOSE: To set monuments necessary to partition Lot 2 into parcels 1, 2 and 3 as shown on the accompanying plat.

EQUIPMENT: A 20-second Jena Theodolite, 300 ft. Lufkin steel tape, and other miscellaneous tools.

INDIVIDUALS: Witnesses include the property owner and the field crew consisting of Duane Smith and Delbert Hanson. This survey was conducted between January 23 and April 1, 1981.

PROCEDURES: This survey utilized a closed-random traverse with preliminary closures being 1/20,000 prior to balancing. Ties were made to existing monuments on Lot 2, giving control to partition Lot 2 as shown on the plat. Meridian is based on the North line of the NE $\frac{1}{4}$, SW $\frac{1}{4}$ of Section 21, S 89° 03' 09" E, as recorded on Survey No. RM 2-35.

RESULTS AND COMMENTS: The four corners of Lot 2 and the CW 1/16 Corner of Section 21 were found intact as recorded on Survey No. RM 2-35. I set monuments on and within the boundaries of Lot 2 to partition into Parcels 1, 2, and 3.

CORNERS FOUND:

- 1) CW 1/16 Corner, found 1966 BLM Brass Cap from which bears:
 - a. 8" D. Fir, N 13° E, 17 $\frac{1}{2}$ lks.
 - b. 18" Oak, S 11° E, 41 $\frac{1}{2}$ lks.
- 2) C $\frac{1}{4}$ Corner, found 1966 BLM Brass Cap from which bears:
 - a. 24" D. Fir, S 85° E, 27 lks.
 - b. 16" Madrone, N 50° W, 80 lks.
