DESCRIPTIONS:

Parcel 1

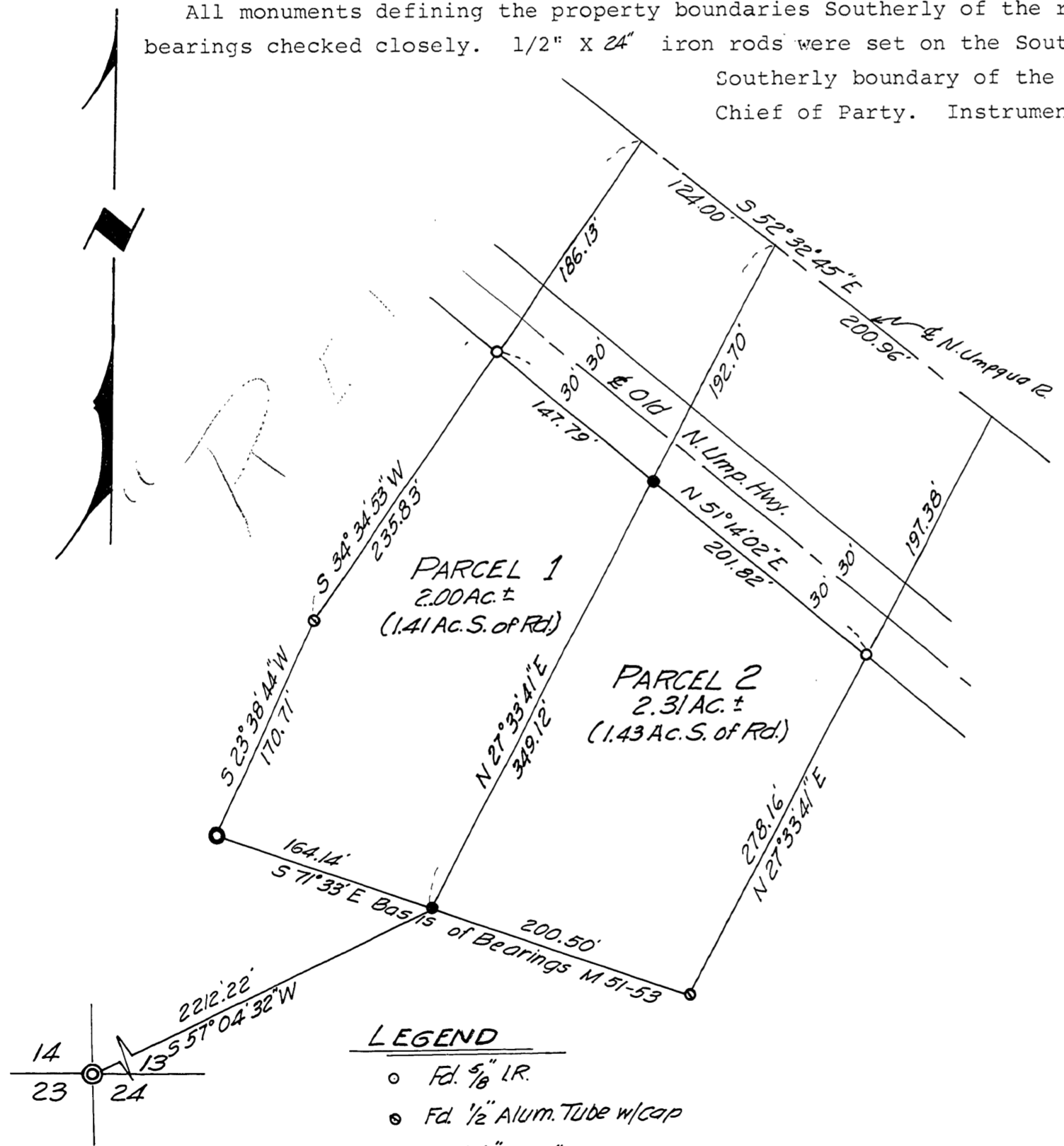
Beginning at a 1/2 inch iron rod from which the Section Corner common to Sections 13, 14, 23, & 24, T. 26 S., 4 W., W. M. bears S. 57°04'32" W. 2212.22 feet, thence N. 27°33'41" E. 541.82 feet to a point in the center of the North Umpqua River, thence N. 52°32'45" W. 124.00 feet along the center of the North Umpqua River to a point, thence S. 34°34'53" W. 421.96 feet to a 1/2 inch aluminum pipe, thence S. 23° 38' 44" W. 170.71 feet to a brass cap set in concrete, thence S. 71°33' E. 164.14 feet to the point of beginning, containing 2.00 Acres, more or less, in the S. W. 1/4 of Section 13, T. 26 S., R. 4 W., W. M., Douglas County, Oregon and excepting therefrom the right-of-way of the old North Umpqua Highway.

Parcel 2

Beginning at a 1/2 inch iron rod from which the corner common to Sections 13, 14, 23, & 24, T. 26 S., R. 4 W., W. M. bears S. 57°04'32" W. 2212.22 feet, thence S. 71°33' E. 200.50 feet to a 1/2 inch aluminum pipe, thence N. 27°33'41" E. 475.54 feet to a point in the center of the North Umpqua River, thence N. 52°32'45" W. 200.96 feet along the center of the North Umpqua River to a point, thence S. 27°33'41" W. 541.82 feet to the point of beginning, containing 2.31 Acres, more or less, in the S. W. 1/4 of Section 13, T. 26 S., R. 4 W., W. M., Douglas County, Oregon and excepting therefrom the right-of-way of the old North Umpqua Highway.

Narrative:

All monuments defining the property boundaries Southerly of the roadway were in place. Recorded distances and bearings checked closely. 1/2" X 24" iron rods were set on the South right-of-way line of the County Road and on Southerly boundary of the property. The survey was performed by L. Fanning, Chief of Party. Instruments used were a Wild T-1 and 300 foot chain.
